## Sepsis Alliance Connect- Terms of Service

**IMPORTANT- PLEASE READ THESE TERMS OF SERVICE CAREFULLY AS THEY CONTAIN IMPORTANT INFORMATION REGARDING YOUR RIGHTS, REMEDIES AND OBLIGATIONS.**

Welcome to Sepsis Alliance Connect (the “Service”), a service of Sepsis Alliance in partnership with Selfhelp Community Services, Inc. (“Selfhelp”). The Service is a tool to connect you to other members of the community as well as informational resources available from Sepsis Alliance and elsewhere on the world-wide web.
