## 1. Frequently Asked Questions

### What is Sepsis Awareness Month, and why is it important?

In 2011, Sepsis Alliance designated September as Sepsis Awareness Month. Every September since, we've invited individuals, healthcare professionals in every area of medicine, and organizations big and small to help save lives by raising awareness of the leading cause of death in U.S. hospitals: sepsis.

<u>Sepsis</u> is the body's life-threatening response to infection. It affects 1.7 million people and takes 350,000 adult lives in the U.S. every year – more than from prostate cancer, breast cancer, and opioid overdose combined. By raising awareness of this deadly condition, we can increase understanding of its signs and symptoms and the need for urgent action, helping to save lives.

### What is a Sepsis Awareness Month proclamation?

At the state level, governors have the power to issue proclamations for observances, commemorations, and other occasions. These proclamations bring attention to issues of statewide importance. As part of our larger Sepsis Awareness Month efforts, we encourage advocates to ask their governors to issue proclamations naming September as Sepsis Awareness Month at the state level.

It is thanks to the hard work of sepsis advocates all across the country that as many as 40 states have now recognized the observance over the years!

#### Should I wait until September to submit my request?

Most states require at least a few weeks to process proclamations requests. Since Sepsis Awareness Month is a month-long observance beginning September 1, we recommend getting requests in well before September (see note about deadlines below).

My state issued a Sepsis Awareness Month proclamation last year. Do I need to go through the proclamation request process again?

Yes – proclamations only cover the year in which they are issued. They need to be renewed every year.

### What are the deadlines I need to pay attention to?

Every state sets different deadlines for its proclamations. You can check your state's proclamation deadline by visiting your governor's website, or by scrolling to page 5 of this document.

Be sure to check your state's deadline and submit your request within the timeframe specified!

### How do I request a proclamation?

The fastest, easiest way to request a Sepsis Awareness Month proclamation is to visit the **Sepsis** Alliance Voices Grassroots Action Center. There, you can follow a few short prompts to submit a request letter to your governor.

Some states will not accept letter requests for proclamations. If that is the case where you live, scroll to page 5 of this document to find the link to your state's web form.

Most proclamation request web forms will require template language (some will specify a certain number of "whereas" clauses). Please copy and paste Sepsis Alliance's template language, findable on page 10 of this document, to fill out that section of the form.

### What do I do now?

This is a crucial part of the process – it helps us keep track of which states have already been secured, and which states still need our effort and attention.











### How can I share this news with my local media?

After securing a proclamation from your governor, a great next step is outreaching to media outlets in your area. Media stories about sepsis advocates pursuing proclamations can be an impactful way to extend sepsis awareness in your state and community! Here is a great example from last year, featuring sepsis advocate Carly from Pennsylvania.

An easy way to outreach to local media outlets is by using Sepsis Alliance's Proclamations Media Outreach tool in the Sepsis Alliance Voices Grassroots Action Center. You can type in your address and a list of local media outlets will pop up, along with text of a letter for you to edit.

In the editable part of the letter, you'll want to fill in information about your motivation for pursuing a proclamation, including your personal connection to sepsis. The more that a media outlet can connect to your personal story, the more likely they will be to publish a news piece about your advocacy. See Carly's story above for an example.

### How else can I get involved this Sepsis Awareness Month?

Your involvement doesn't have to end once your proclamation is secured – there are other activities for raising sepsis awareness this September, including the Sepsis Superhero Challenge, social media campaigns, and more! ## 3. Template Proclamation Language

#### A PROCLAMATION RECOGNIZING SEPTEMBER 2023 AS SEPSIS AWARENESS MONTH

Whereas, September has been nationally recognized as Sepsis Awareness Month by Sepsis Alliance to bring awareness to sepsis, the body's life-threatening response to infection, which can lead to tissue damage, organ failure, and death; and

Whereas, according to the CDC, sepsis affects 1.7 million Americans and takes 350,000 adult lives every year in the United States – more than from the devastating health crises of prostate cancer, breast cancer, and opioid overdose combined; and

Whereas, each year, more than 75,000 children in the United States develop severe sepsis and 6,800 of these children die; and

Whereas, communities that have historically lacked access to high-quality healthcare, including some communities of color and individuals experiencing poverty, experience a disproportionate burden of sepsis-related suffering; and

Whereas, sepsis is the number one cost of hospitalization in the United States, at \$62 billion annually; and

Whereas, sepsis survivors have a shortened life expectancy, are more likely to suffer from an impaired quality of life, and often experience after-effects such as amputations (14,000 per year in the United States) and Post-Traumatic Stress Disorder; and

Whereas, sepsis is the second-leading cause of pregnancy-related mortality in the United States – and the United States has one of the highest maternal mortality rates in the industrialized world; and

Whereas, the growing problem of antimicrobial resistance is steadily increasing the frequency of sepsis cases, and making effective sepsis treatment more difficult; and

Whereas, despite the severe danger and widespread occurrence of this illness, a survey conducted by Sepsis Alliance found that less than 15% of U.S. adults can identify the symptoms of sepsis; and

Whereas, the signs of sepsis can be remembered with the mnemonic "TIME," which stands for "Temperature," "Infection," "Mental decline," and "Extremely ill"; and

Whereas, awareness of the signs and symptoms of sepsis along with rapid diagnosis and treatment of sepsis can save lives and improve outcomes for sepsis survivors, as the risk of mortality from sepsis increases by 4-9% for every hour treatment is delayed; now, therefore, be it

Resolved, that we hereby recognize September as Sepsis Awareness Month.
